#### 2:53 AMA Presentation – Earl Peachy

#### 1. Board member election

The present board members of AMA are Ivan Beachy, Daniel Bontrager, Vernon Miller, Earl Peachy, and Alvin Stoltzfus. Daniel Bontrager's term is expiring in 2006. Slate of candidates are Daniel Bontrager (Rosewood Fellowship, Shipshewana, IN), who is eligible for re-election, Paul Beachy (Grace Mennonite Fellowship, Bastrop, TX), and Philip Beachy (Messiah Fellowship, Millersburg, OH). Daniel Bontrager re-elected to a four year term.

#### 2. Secretaries Report by Ivan Beachy

Love offering was over 124,000, which was distributed among 126 AMA field staff, at approximately \$85 @ share, which is approximately \$3000 @ married couple and \$900 @ single youth serving a full year. The AMA auditors financial report is not yet completed at the time of this meeting, but will be made available for later distribution. If you want to receive an audited statement, contact Ivan Beachy at the information listed in the ministers directory. The monthly cash flow statement is available for pickup at the AMA display table. An overview of the 2005 finances includes Jan 1<sup>st</sup> starting balance \$335, 762, plus contributions of 1,400,000, plus designated funds in

amount of \$362,000, plus channeled funds in amount of \$153,000, for a total revenue of over \$2,000,000, leaving a Dec 31<sup>st</sup> ending balance of 355,000. It is requested that layette bundles for Paraguay now be delivered in travelers' luggages instead regular freight shipment. If you are traveling to Paraguay and have room available in your luggage, please contact Ivan Beachy.

#### 3. Recruiters Report - Ray Stutzman

The need for personnel for the growing work continues, as well as replacement staff. Encouraged ministers to give suggestions for missions staff; do not worry that it "may not work out". Immediate needs were presented, as well as upcoming vacancies. There is a particular need for a midwife, RN or LPN in Paraguay. In Kenya, Merle Beachys are coming home on extended furlough, being replaced by Melvin Bontrager during this time. Dave Stoltzfus's and Randy Lapps are taking back to back furloughs. Earl Peachys will cover their leave of absence.

## 4. Overview of Field Report – Earl Peachy

AMA mission churches ordained six brethren in the past year, which were Elisha Otieno, John Awounda, John Omandi, Joseph Musikali in Kenya, Rogelio Guterrez in Belize, and Arthur Nisley to the office of Bishop in El Salvador. With regret, it was also reported that one ordained Kenyan brother (and his wife) have been excommunicated and he has been relieved of his ministry. AMA is available to give presentations to your congregations about the work of AMA, including weekend seminars on missions.

## 3:20 Vote for Bishop Committee member – conducted by Moderator

The current Bishop Committee is Elmer Schmucker, Glen Yoder, Joe Peachy, John U Lapp, and Tim Miller. Elmer Schmucker's term is expiring in 2006. By policy, a Bishop is ineligible for reelection to a second term. Ballots were taken to select a slate of three candidates to be voted upon at tomorrow's business session.

#### 3:22 MIC Presentation - Melvin Glick

Expressed appreciation for funds and staff, short-term and long term. MIC Financial Report is available at MIC booth for distribution.

- 1. Belguim report Acceptance of Americans in western Europe has declined, and this has its effect upon the mission's acceptance Paul Yoder family and staff are an oasis in the desert.
- 2. Ireland report Daniel Yoder representing Dunmore East Christian Fellowship. Greetings from Brother William McGrath, in good spiritual and physical health, now over 75 years old. Thank you for funds donated for support of William and Alice McGrath. Ed and Lois Yoder have joined the Ireland mission in Nov 2005. One of the mission goals from the start was to become self-supporting. Grateful to report that for the past 2 years the mission has become almost self supporting through building and selling wooden lawn furniture. A new shop was built in the fall of 2005. The church is growing slowly but surely. Gave an overview of various individuals who attend church from around Western Europe. A young French brother may attend Faith Builders next year. Eight to ten Choice Books racks are serviced. Requested prayer and gave invitation to visit.
- 3. Faith Mission Home Reuben Yoder Faith Mission currently cares for 60+ children with special needs. Need several staff girls in May, 2006. After 24 years of service, Reuben Yoder is transitioning leadership to Paul Beiler, who has been training supervisor for several years. Reuben shared in this final report that he has attempted to direct Faith Mission over the years in good faith and conscience, providing an environment conducive to spiritual growth for staff, so they return to home congregations better prepared to contribute there. Apologized for failures during his time as director. Thanked people for support during trying times, in particular during the lawsuit brought against Faith Mission in the mid-80s.

- 3. Northern Youth Programs report Darryl Nisley Introduced a number of current workers who are attending this meeting. Expressed spiritual warfare encountered and Spiritual mentoring performed. Financial pressure has caused thorough evaluation of programs, but God has supplied sufficient funds. Shared numerous present and future staff needs. If you know of anyone who would qualify, please advise.
- 4. Hilicrest Home Ken Nisley My God shall supply all your needs. Last year we put out a plea for youth for staff. Good response, patient census increased from a low of 72 to 88, with possibilities for 90. Pray for administrative team.
